

## Drawing summary:

\* Ticket prices: one for \$10, three for \$25, or six for \$50

\* Prize drawing will be held at the Annual Meeting of the Fort Lauderdale Woman's Club, 20 South Andrews Avenue, Fort Lauderdale, FL 33301 at 12:45 pm on Friday, January 15, 2016

\* You do not need to be present to win

## Read the rules below:

1) Each purchaser of a drawing ticket must be at least 18 years old and only one individual's name may be associated with each ticket. All federal, state and local rules shall apply to the drawing. Tickets may be purchased by e-mail from the website or in person from the Fort Lauderdale Woman's Club member. Payments for online tickets may only be by credit or debit card. Any credit or debit card payment that is denied shall disqualify the pending purchase. All online ticket sales shall be by the internet at the drawing website <u>https://www.blacktie-southflorida.com/calendar/event-details.cfm?id=13179</u>. All e-mail communications will be sent to the e-mail address provided by a purchaser as part of the purchase. Such communications shall include purchase confirmation and drawing ticket number. Purchaser is required to provide to the Fort Lauderdale Woman's Club a valid, functioning e-mail address and mailing address.

2) By submitting an entry, each purchaser acknowledges having read and agreed to abide by these Official Drawing Rules.

3) Once a ticket has been purchased, it is non-refundable except in event the drawing is cancelled in accordance with the drawing regulations of the State of Florida.

4) Each ticket shall be sequentially numbered from the first ticket sold through the last ticket number sold. The drawing period shall be from the date the first ticket is sold, through January 14, 2016 or such earlier date as the maximum number of tickets is sold. Online ticket sales will be closed at any time before the drawing. The drawing will be held on Friday, January 15, 2016.

6) Each online purchaser will be sent a ticket and receipt via e-mail that will identify the purchaser's unique drawing ticket number(s). The original printed drawing ticket will be retained by the Fort Lauderdale Woman's Club and the stub entered into the drawing along with the stubs of all other tickets sold. U.S. Postal regulations prohibit the mailing of drawing tickets.

7) ) The drawing shall take place at 12:45 pm at the Fort Lauderdale Woman's Club on January 15, 2016. At the drawing the winning ticket stub shall be chosen by picking it from a large container containing all ticket stubs, thoroughly mixed. The winner does not need to be present at the drawing to win.

8) The holders of the winning ticket shall be notified by telephone and/or e-mail and Certified U.S. Mail at the address provided by the purchaser.
